GENERAL INSTRUCTIONS FOR MBBS ADMISSION FOR THE ACADEMIC YEAR 2025-26

1. Students must report at Academic Section, Ground Floor, Medical College Building, ESIC Medical College, Sanathnagar, Hyderabad – 500038 for UG (M.B.B.S) Admission on or before date indicated on their allotment letter issued by MCC/KNRUHS, Telangana. If any student fails to report before the last date, his/her admission will stand cancelled and the same will be intimated to concerned authorities.
2. One of the parent/guardian who signs as Surety must accompany student at the time of admission or when surrendering of seat is done, as some documents need to be signed by them. Student & Parent must carry their Original ID proof. **Insured Person presence is mandatory for ESIC Ward of IP Quota Admission.**
3. The admission offered to a candidate will be only provisional. Medical Counselling Committee(MCC) and KNRUHS-Warangal are the final authorities.
4. The Admission process may take one day or more than one day depending upon the fulfillment of all the required documents to be submitted by the students. Outstation candidates are advised to make their own staying arrangements accordingly.
6. The Original documents of the students are retained by the College authorities. Therefore, all the students are instructed to keep at least 3 sets of Xerox copies of Original documents with themselves for future use.
7. Seat surrender Procedure will be duly followed as per MCC/KNRUHS guidelines.
8. Kindly generate the Online seat surrender receipt and contact the Academic Section, Ground Floor, College Building, ESIC Medical College, Sanathnagar, Hyderabad – 500038 after seat surrendering.
9. Name & DOB of the candidate in Aadhaar card should match with details in their SSC/Intermediate certificates. In case of mismatch, students are advised to make necessary correction including updating of individual mobile number from any E-service centers before coming to the admission process.
10. All Electronic certificates submitted by the candidates should be e-verified with tick mark.

11. If any certificates submitted by the candidates are issued in their local language, the English version of the same must be submitted during the admission.

12. Gap certificate (If applicable) must be issued by Tahsildar/ District magistrate.

13. Proof of online declaration (during admission) on anti-ragging policy (at www.antiragging.in) should be submitted.

14. Only the candidates of other State Board are required to submit Migration Certificate during admission.

15. The Bonds are to be made only in the Govt. of Telangana Bonds.

16. All the students are instructed to bring all the Documents & Bonds specified in the Checklist for Admission process.
